Me2accessibility's accessibility evaluation assessments incorporate a variety of measures, which can include: (i) conducting automated testing using a variety of proprietary and external tools; (ii) performing visual inspection, code inspection and manual testing with a keyboard; and, (iii) testing with adaptive technologies, such as screen readers and speech recognition software.
